

# INFORMATION FOR ALL MEMBERS ATTENDING THE 92<sup>ND</sup> ANNUAL GENERAL MEETING (AGM) OF TCC CREDIT CO-OPERATIVE LIMITED ON SATURDAY, 31 MAY 2025

## 1. TRANSPORT & REFRESHMENTS

## 3. LOYAL MEMBERSHIP AWARD

## GUIDELINES FOR CANDIDATES STANDING FOR ELECTION AT THE 92<sup>ND</sup> ANNUAL GENERAL MEETING OF TCC CREDIT CO-OPERATIVE LIMITED

### 1. ELIGIBILITY – BOARD OF DIRECTORS

As stated in By-law 14.13, an individual is not eligible for membership of the Board of Directors of TCC, or to remain a member of the Board, if:

- a) He/she is under 18 years of age;
- b) He/she is not:
  - i. a citizen of Singapore; or
  - ii. resident in Singapore (subject to Section 60(2) of the Act); unless approved by the Registrar;
- c) He/she is an undischarged bankrupt (whether adjudicated in Singapore or by a foreign court);
- d) Except with the Registrar's written approval, he/she has been convicted (in Singapore or elsewhere) of any offence involving fraud or dishonesty (not being an offence under the Act);
- e) He/she has been convicted of an offence under the Act;
- f) He/she has been dismissed as an employee of a co-operative society;
- g) Except with the Registrar's written approval, he/she has previously been removed or suspended by the Registrar from the Board of any society under Section 94(1) or 94A(1) of the Act;
- h) He/she becomes ineligible under any of the By-laws;
- i) He/she has been an Ordinary Member of TCC for **less than three years**, unless approved by a majority of **TCC's Ordinary Members** at the AGM;
- j) Except with the Registrar's written approval, he/she has failed to complete mandatory training or meet other requirements specified in the Rules within the designated timeframe.

**Note:** The Board shall **suspend any Board Member or key employee** if proceedings are instituted against them for an offence involving fraud or dishonesty.

### 2. GUIDELINES FOR NOMINATION OF CANDIDATES TO THE BOARD

- a) All members of the Board of Directors shall be subject to **nomination for re-election**.
- b) Nominations must be submitted using **the prescribed Nomination Form**, duly completed and signed by:
  - the **Candidate**,
  - a **Proposer**, and
  - a **Secunder**.

*(All three must be Ordinary Members of TCC.)*
- c) The Candidate, Proposer, and Secunder must be **present in person** when submitting the Nomination Form to the Secretary or a designated representative, to confirm the Candidate's consent.
- d) The Candidate, Proposer, and Secunder must present their **NRIC for verification**.
- e) The Secretary or designated representative will verify that the form is complete and in order **after the nomination deadline**.
- f) Incomplete or improperly filled nomination forms may be declared null and void.
- g) Nomination Forms can be collected from the Secretary at **95 Killiney Road, Singapore 239537**, during office hours upon request.
- h) All completed Nomination Forms must be **submitted in person** to the Secretary at TCC Credit Co-Operative, 95 Killiney Road, Singapore 239537, **by 6:00 PM on 23 May 2025**.

**Note:** Candidates standing for election must attach a recent passport-sized photograph in the space provided on the Nomination Form.

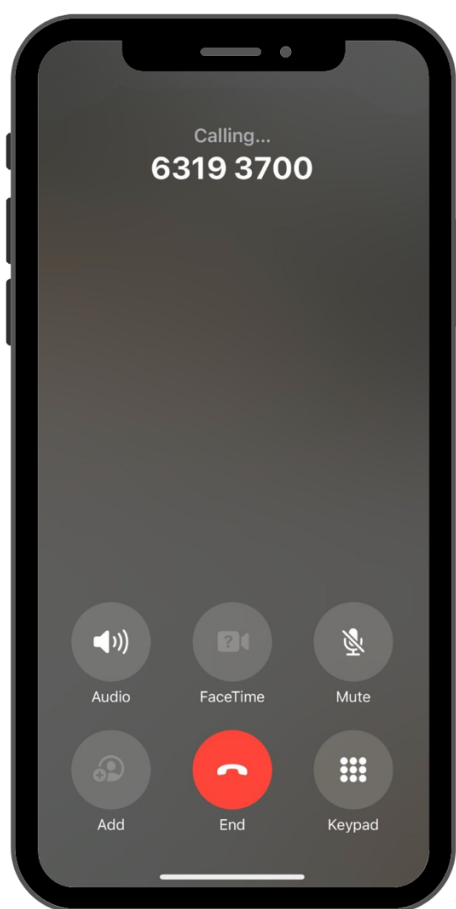
## Dividend Payments

As in previous years, **dividend payments by cheque will not be issued** on the day of the Annual General Meeting (AGM). Instead, **dividends will be credited directly into members' TCC Savings Account**.

Members may access their dividend funds in the following ways:

### Option 1: Use TCC's Robo-Teller (Auto-Bank Service)

Available from 2nd June 2025, members can transfer their dividend from their TCC Savings Account to their POSB/DBS Account using the Robo-Teller system.



**1. Dial 6319 3700 and press 1 for Robo-Teller.**

**2. Key in your Membership Number.**

- If you're unsure of your Membership Number, please call 6319 3700 for assistance.

**3. Enter your Access Code:**

- First-time users should use their Date of Birth as the default access code.
- E.g. for someone born on 4 July 1958, key in 040758.

**4. Press 3 for Auto-Bank Service:**

- Enter the amount (\$) you wish to transfer, followed by an asterisk (\*).
- E.g. to transfer \$40, key in: 40\*
- Transfers to your POSB/DBS account will be processed within 48 hours.

**Note:** Ensure TCC has your correct POSB/DBS account number on file.

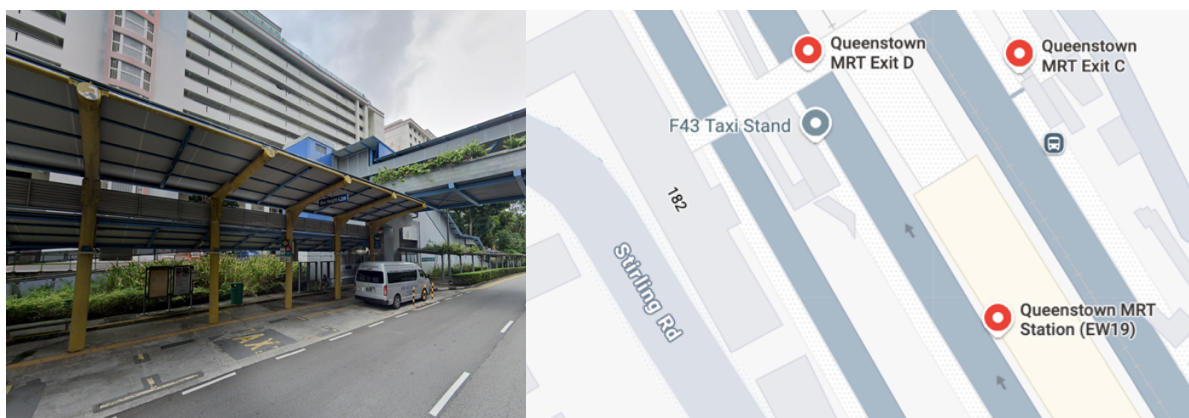
